AIMS AND SCOPE

International Organizations (IOs) – including regional inter-governmental organizations – are central and influential actors on the international scene. They are important forums for cooperation between States, they fulfill particular regulatory functions, and they contribute considerably to the creation and enforcement of international law.

This course analyzes the functions and limitations of international organization with a special focus on the creation, legal status, competencies, decision-making processes and internal organization of IOs. The first sessions reflect on the historical development of institutionalized international cooperation, the functions of IOs, their powers, privileges and legal personality. The course also deals with the rules applicable to the internal bureaucracies and staff of IOs, including access to IOs and the rights and obligations of the international civil service.

The course refers to existing IOs, especially the United Nations, to exemplify the tasks, functions and inner workings of IOs, in particular in the areas of conflict stabilization, human rights, economic development and environmental protection. However, the course is not an in-depth introduction to the numerous existing IOs active in these areas.

- Understanding the nature, types, legal status and functions of International Organizations in international affairs.
- Understanding the nature, status, rights and obligations of the international civil service.
- Identifying and analyzing the at times conflicting legal, political and economic interests involved in the activities of IOs.
- Recognizing and critically evaluating the strengths, weaknesses and challenges in international political organization.
- Formulating and debating possible solutions to these challenges and problems in international and multicultural environments, supported by original argumentation on an advanced level.

LEARNING OUTCOMES

- Understanding and being able to explain the structure, competencies and internal functioning of IOs.
- Understanding the professional role and applicable legal regime of the international civil service, including the legal status and privileges of international civil servants.
- Knowing and interpreting the scope and limits of immunities of international organizations and their staff.
- Understanding the legal regime of international responsibility of IOs.
- Critically analyzing the strength and weakness of IOs compared to other international and regional actors in light of their status and functions.
- Organizing and adapting arguments in a discussion and being able to independently analyze cases that relate to IOs.

SCHEDULE

Note: The detailed schedule of the course may be modified as a consequence of circumstances that may arise due to the Covid-19 pandemic and in order to accommodate guest speakers. Some of the assigned readings will be further specified regarding the required page ranges.

Students will find excerpts of the assigned cases on the online platform of the course. While it is not necessary to read the entire cases, students should be familiar with the excerpts and the basic facts of the cases (i.e. parties, legal questions, decision by the court).

PREVIOS KNOWLEDGE REQUIRED

Previous knowledge of international affairs, international organizations and the role of norms in international relations is welcomed but not strictly necessary.

RELATION TO OTHER MASTER'S COURSES

No enrollment restrictions. This course is part of the Master's module "International Legal and Institutional Order", together with "Ordenamiento Jurídico de la Comunidad Internacional".

Students who come from undergraduate studies other than those specified in the official regulations of the master's degree must have attended prior the following "Preparatory Courses":

TEACHING METHODS

Class sessions will consist of lectures, debates (with the entire class and within smaller groups) and assignments (both in and outside class). The sessions will be devoted to learning, challenging and applying the different aspects and concepts of International Organizations Law presented during the course. Activities will be based on prior announced research tasks, small test or group activities. Analysis of cases will give you the opportunity of applying the concepts to real world situations and will allow you to test your understanding and knowledge with other class members.

The teacher will assume that students have studied the assigned readings in advance.

Note: Both the methodology of the course and the evaluation may be modified as a consequence of circumstances related to the Covid-19 pandemic.

GRADING

The course offers the options of single and continuous evaluation. Students may choose the option they prefer by filling out a form available at the secretary's office of the affiliated center within the deadlines established by CEI's regulations. The minimum compulsory attendance for the two evaluations is 80% of the sessions (9.5 sessions, 2 hours each).

Continuous evaluation: The evaluation will combine grades for attendance and participation (15%), three continuous evaluation assignments (15% each) and a final exam (40% of the final grade). Late submissions of assignments will not be accepted, unless an exception has been requested and granted before the deadline. If a student misses an assignment unexcused, the assignment will count as 'not presented' without the possibility of an alternative assignment.

In case of the single evaluation, the final grade will consist of the grade for the final exam (100%).
